Again, there was a chorus that said optometrists had no business practicing

medicine, and that if someone wanted to prescribe, they should go to medical school and become a real doctor. The year 2000 saw the arrival of oral pharmaceutical agents. The critics were vocal in their disgust, stating that vision training and the twenty one point exam were what optometry was all about, and that we were abandoning our heritage.

# LEGISLATIVE UPDATES: BY DR. ANNETTE HANIAN

---

For the fourth year in a row, we have a bill introduced and moving through the AZ Legislature that improves the practice of Optometry. We are currently 3-0 and are trying hard to continue the success that we have had at the Capitol.

Senate Bill 1224 has Senator Linda Gray as its primary sponsor and several other legislators signed onto the bill as sponsors: Senators Linda Lopez, Al Melvin, Michele Reagan, Steve Yarbrough, Steve Gallardo, David Lujan, Rick Murphy, David Schapira, Steve Smith and Don Shooter with Representatives Richard Miranda, Carl Seel, David Smith, Debbie Lesko and Nancy McLain. There are several other legislators that are supportive of this bill, but not signed on as sponsors.

SB 1224 would require insurance provider panels, Like the Arizona Foundation, to include Optometrists if they provide medical eye services. This bill would also end the practice of some insurance companies, like United Health Care, of requiring ODs but not OMDs to join their vision plan before they can be providers on the medical plan. This bill, if signed into law, will make access to ODs much easier for patients across the State.

At the time of writing of this article the bill is moving through the Senate. Emails, faxes and phone calls from ODs across the state to the legislators are very helpful. It is our grassroots that set us apart from the large insurance companies and their 'pack' of lobbyists. We are have opposition with a lot of influence and money, but OD participation is the essential element in counteracting this opposition.

## HOW A BILL BECOMES LAW IN ARIZONA

This is a general and very brief description of the major steps of the legislative process a bill must go through before it is enacted into law. As you read through these steps, keep in mind that it is easier to stop a bill at anyone of these levels than it is to get a bill moving to the next stage.

An Arizona Bill is introduced in the House by a Member, a group of Members, a Standing Committee or a Majority of a Committee, after being written in proper form by the Legislative Council. A bill cannot be introduced by anyone other than a member of the legislature. An individual citizen or organization cannot introduce legislation. Our Association seeks out a legislator that is willing to put their name to the bill and support it. They put their reputation on the line for a bill we encourage. Also, the legislator's reputation and relationships with their colleagues and the political climate can affect whether a bill moves through the stages.

Bill is branded (assigned a number).

First Read and referred by the Speaker to appropriate Standing Committees and to the Chief Clerk for printing and distribution.

Committees consider Bill (may include hearings, expert testimony, statements from citizenry). Committee reports and recommendations to Whole House. Committee on Rules determines if Bill is constitutional and in proper form. The democrats and republican have caucus meetings to discuss issues related to the bills introduced and to plan a strategy for votes.

Committee on Rules places Bill on Active Calendar and Speaker sets order in which measures will be considered.

Third Reading-Roll Call: Every Member present must vote (unless excused and no Member may vote for another Member). If passed by Senate (either in identical form or amended by adding or deleting material), Bill is sent back to House...Third Reading --Names called alphabetically and unless excused, each Senator present must vote on each measure.

Committee of the Whole: Entire membership of Senate acts as one committee. Debate, amendments and recommendations on Bills on Calendar.

Committee on Rules' agenda becomes the calendar for Committee of the Whole and after 5 days President designates which measures are to be placed on Active Calendar of the Committee of the Whole.

Second Reading-- President refers Bill to appropriate Standing committees. Committees consider Bill (May include hearings, expert testimony, statements from citizenry). Reports recommendations to entire Senate. House Bill is First Read in the Senate and laid over one day. If passed by House, Bill goes on to the Senate. Committee of the Whole. Informal session of entire House membership acting as one committee. Debate, amendment, Recommendations on Bills on Calendar.

If Bill is identical to measure originally passed by House, goes to Governor.

If Bill comes back to House in different form (amended either by addition or deletion of material) Bill may be accepted in new form and sent to Governor.

Bill is sent to Conference Committee made up of Representatives appointed by the Speaker and Senators appointed by the President -- each with own idea of how Bill should Conference committee "mends" Bill by accepting original version, by adding new material, by deleting language or in some way compromising disagreements. A Conference Committee Report is sent back to each House for adoption and after Final Passage, Bill is sent on to Governor.

## WHAT IS THE OPTOMETRIC RECOGNITION AWARD PROGRAM?

The Optometric Recognition Award (ORA) program is designed to recognize and motivate doctors of optometry in continuing their education with the objective of improving the quality of optometric care.

The initial award requirements are satisfactory completion of 150 credit hours of continuing education over the three consecutive year period prior to the award year. However, the award requirements may be completed in less time. Transcript quality courses offered by an accredited institution of higher learning will be given double credit hours for ORA purposes upon successful completion of the course and exam. Verification from the provider is required.

The enrollment fee is \$40 to cover direct costs for the ORA Award Certificate and office procedures.

Five categories, designed to cover a variety of learning experiences, are approved for the Award.

<b>CATEGORY 1</b>	Requires a minimum of 90 hours for courses taken from AOA Approved Providers. All 150 hours may be taken in Category 1.
<b>CATEGORY 2</b>	For courses taken from non-approved providers (that is, not on the AOA list of Approved Providers), and has a maximum limit of 30 hours for the three years.

**Optometry Cares®**—The AOA Foundation and the American Optometric Association (AOA) are pleased to announce the 9th annual funding of the Healthy Eyes Healthy People® (HEHP) State Association Grants. The 2012 HEHP grants are made possible through a generous grant from Luxottica. Over the course of the past eight years, the HEHP sponsors have contributed a total of \$1,152,000 for more than 300 HEHP grants, which have gone directly to state association community outreach projects. These projects have served to educate the public and allied groups on the importance of vision care and have improved the lives of thousands of patients.

In the past, the AOA has elected to directly link HEHP grants to federally-defined Healthy People® objectives. However, in an effort to challenge the ineffectual status quo, no change in vision objectives for children from HP 2010, and encourage the growth of community-based solutions to tackle undiagnosed children’s vision disorders, this year’s HEHP grants will focus directly on Healthy People® 2020 (HP 2020) children’s vision objectives.

Potential grantees should be aware that despite the current efforts to provide vision care for children, there is considerable evidence of disparities in both the access and utilization of professional vision care among children. Sadly, appropriate assurance of access to early and timely comprehensive vision care services by a professional eye care provider is often being sidetracked by low sensitivity vision screenings that produce an inordinate number of “false negatives” and /or symptomatic children simply not being referred to professional eye care services directly.

The AOA believes that this public health emergency in children’s vision and eye health must be resolved and that targeted efforts and new data from carefully selected 2012 HEHP grant applicants will be helpful in steering a course of action to more fully address the vision and eye health needs of America’s children.

To be responsive to this Funding Opportunity Announcement (FOA), applicants should address one of the following two objectives\*:

- V-1 Increase the proportion of children age 5 years and under who have visited (had an eye examination by) an eye care provider in the preceding 12 months.
- V-2 Reduce visual impairment in children and adolescents.

\*Note: greater consideration will be provided to those grants that involve UV (Sun) protection.

While complete guidance has been developed for the objective (V-2) originally included within the federally-defined HP 2010 vision objectives and continued for HP 2020, the AOA has developed initial guidance for meeting the alternate (V-1) objective and has posted further materials on the AOA’s 2012 HEHP Web site at: [www.aoa.org/x15198.xml](http://www.aoa.org/x15198.xml)

In order to address the alternate (V-1) objective, successful grantees should develop and clearly describe methods they will use to increase access to comprehensive vision and eye health care for children and design ways to provide non-identified data; including but not limited to, patient demographics, vision and eye health diagnosis and treatment. Additionally, any secondary prevention efforts that aim to find vision and eye health problems early so that action can be taken to minimize the risk of progression of eye diseases or vision disorders, should include a detailed description of program elements that target and use sufficient and sensitive methodologies.

The overwhelming thrust behind the alternate (V-1) objective is to ensure that all children identified as “at-risk” for a vision-related problem receive appropriate diagnosis afforded through a comprehensive eye exam and increased access to needed treatment and follow-up care. In addition, program elements should aim to address traditional hurdles at-risk children face in directly accessing a comprehensive eye examination, including diagnosis, treatment and follow-up care. Applicants should be responsive to the fact that 83% of children from families at or below 200% of the federal poverty level have unmet vision and eye health care needs.

The AOA continues to work with U.S. agencies to strengthen their resolve to establish a more comprehensive approach to children’s vision and eye health protections. Your thoughtful proposals will continue to be helpful in this regard.

States may apply for more than one grant and each grant is worth up to \$5,000.

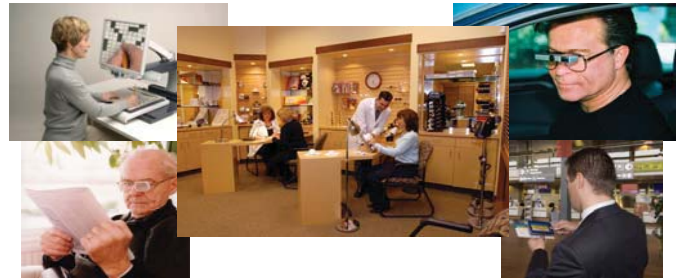

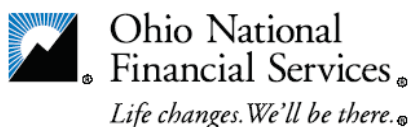

## HOW A BILL BECOMES LAW IN ARIZONA

After Bill is received by Governor having been passed by both House and Senate, the Governor may sign Bill or allow Bill to become law without his signature if he/she takes no action during next five days (or ten days after adjournment). Then Bill becomes law - a part of the Arizona Revised Statutes.

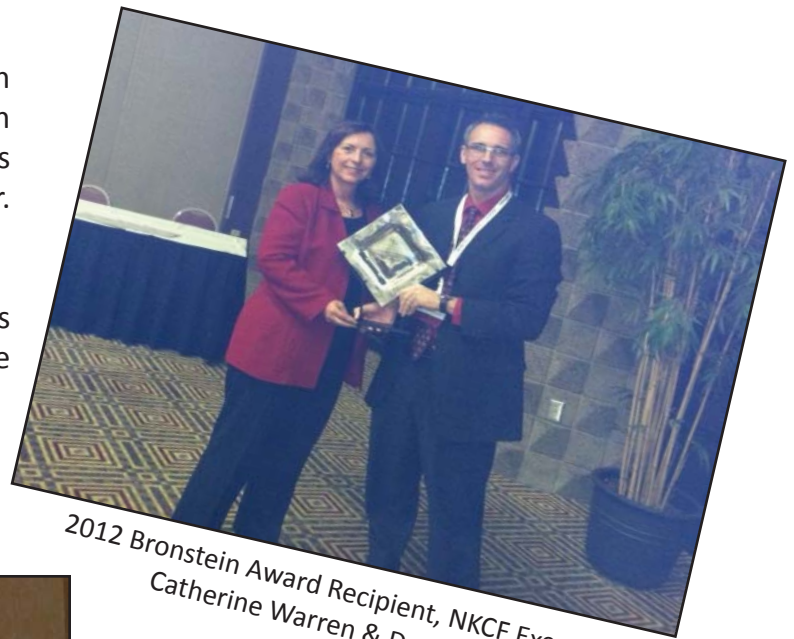
The Governor may veto Bill, but must return Bill to House stating his reasons. The House and Senate may override the Governor's veto by a two thirds vote (or three-fourths, if an emergency measure). Arizona Revised Statutes Bill may be rejected and sent to a Conference Committee pass.

As you can see, it is much easier to "kill" a bill than to "pass" a bill. There are numerous stages at which a bill can have its progression through these stages halted. Sometimes, we can use this in our favor. Sometimes, it will work against us.

An average of 1400 bills are submitted by legislators each session. An average of 320 are signed by the Governor each session.
